The candidates also addressed the following: affordable housing and density issues; Proposition H (infrastructure and Councilperson Mark Kersey's plan); the Citizen's Plan(proposes to raise the hotel tax to help pay for tourism promotion and a Convention Center expansion); public safety including an adequately resourced police department; Charger Stadium location; homelessness; historical preservation and conservation; short term rentals, increasing housing stock within communities; Vision Zero(project to reduce pedestrian and bicyclist's deaths on streets and sidewalks); deferred maintenance, especially in Balboa Park; and the use of bonds.
