# 2. Comments on Non-agenda Items

- a) Public
  - i) Paul Chance from Presidio Heritage Trust attended the meeting to introduce the organization and coordinate efforts with MHTC and Old Town organizations to support Presidio Park efforts.
  - ii) Belinda Appleyard came to the meeting to request a letter to Chris Ward for to conduct bike accessibility assessments while the University Street to Washington Street west ramp is closed for repair. Ultimately, Belinda is in favor of converting the ramp to a bicycle lane. Judi Tentor motioned that MHTC send a letter; Peter seconded. The letter will be assigned to Judi to draft.
  - iii) John Hartney from Neighborhoods for Clean Elections attended the meeting to introduce himself and provide info on SDCleanElections.org
  - iv) Brittany Bailey from Chris Ward's office spoke about short-term rentals and a referendum from Airbnb to oppose the measure. The city council is considering a styrofoam ban in October. The Mayor's convention center initiative did not secure enough signatures to get on the ballot. The BID conducted a survey to assess public opinion on what should happen with the old library building and the city is considering the input.

- v) Keith Wilson wanted to address the safety of the crosswalk on Washington Street at Albatross.
  West-bound cars are not stopping in the afternoon when the alert lights are not visible. Brittany
  Bailey stated that the city's traffic engineering department is studying the intersection.
